

HANEX® 10-YEAR LIMITED WARRANTY FOR EXTERIOR APPLICATIONS

Hyundai L&C warrants, based on many years of practical experience and knowledge, that limited colors (only the decors listed here) under the Hanex® Solid Surfaces brand are suitable for exterior use against moisture, UV radiation and temperature fluctuations, in compliance with all Hyundai L&C / Hanex guidelines and instructions.

This Warranty applies to the exterior application for following Hanex® colors in 12mm thickness only for these colors change of less than or equal to $5 \Delta E$ units in 10 years under normally predictable circumstances:

- 1. Gloss loss shall not exceed 40% of the matte finish and the paint shall not leach more than the specified delta value for each color for the first 10 years after initial installation. In addition, Hyundai L&C warrants that the Hanex color will remain free of: Flaking, swelling and peeling when the product has been stored, handled, applied and maintained in accordance with Hyundai L&C's technical instructions and all applicable building codes.
- 2. If, during the above period, a Hanex sheet (if it meets the required local or national European construction standards) shows signs of a defect (subject to the limitations set forth herein), Hyundai L&C will, at its option, either provide a free replacement Hanex sheet or refund the original purchase price of the Hanex sheet that Hyundai L&C determines to have one of the above conditions. In order for Hyundai L&C to respond under this warranty, Hyundai L&C must have the opportunity to inspect the product and subsequently provide its warranty services. All decisions regarding the existence of any of the above conditions or manufacturing defects, or in any case concerning this warranty, shall be made by Hyundai L&C and shall be final and binding on the parties.

3. This Limited Warranty applies only to defects occurring within ten (10) years from the date of permanent installation. The Limited Warranty shall apply only if Hyundai L&C is notified in writing within sixty (60) days after such defects either occurred or should have been discovered through the exercise of reasonable care.

Failure of the claimant to notify Hyundai L&C within such period shall automatically relieve Hyundai L&C of any responsibility and/or liability under this Limited Warranty. Hyundai L&C makes no warranty, express or implied (including, but not limited to, warranties of merchantability, fitness for a particular purpose, even if such purpose is known to Seller or arises from a course of dealing) with respect to the Product. Buyer assumes all risk and liability for results obtained from the use of products covered by this limited warranty, whether used singly or in combination with other materials. The warranty contained herein does not apply to Hyundai L&C joint adhesives; it applies only to Hanex sheets.

- 4. This warranty does not apply to damage caused by physical or chemical abuse, vandalism, fire, excessive heat, storm damage, floods, earthquakes, accidents, wars, other forms of acts of God, improper design or installation of Hyundai L&C products, a particular application or selection of products for a particular project or design, parts, components or sealants of other manufacturers used with Hyundai L&C products, or failure of Hyundai L&C products caused as a result of such matters and Hyundai L&C hereby disclaims all liability therefor.
- 5. Hyundai L&C's obligation shall be limited solely to refunding the purchase price of the Hanex sheets or replacing the Hanex sheets for which the claim is made, excluding any costs associated with the manufacture, replacement or installation. In no event shall Hyundai L&C be liable for any special, indirect, incidental, punitive, consequential or similar damages (including, without limitation, damages for lost profits, business interruption or other loss), whether or not caused by Hyundai L&C's negligence, even if Hyundai L&C has been advised of the possibility of such damages.
- 6. This is the only limited warranty made in connection with the sale of Hanex sheets used in exterior application projects. No agent, dealer or other person is authorized to make any warranties, representations or promises with respect to these products. No terms and conditions other than those set forth herein and no oral or written agreements or understandings modifying this Limited Warranty shall be binding upon Hyundai L&C unless set forth in writing and signed by an authorized representative of Hyundai L&C.
- 7. Laws, building codes and safety regulations governing the design, construction and building of equipment vary widely. Hyundai L&C assumes no responsibility or obligation with respect to the selection of the product for installation or the design, engineering and construction of the installation.
- 8. This warranty is conditioned upon the above product being supplied by a Hyundai L&C / Hanex authorized supplier.
